#### Payment terms:

- Invoices issued on the 15<sup>th</sup> of each month, for all sessions booked for the following month. Payment is due on the 1<sup>st</sup> of the month *(for example we'll invoice you on 15<sup>th</sup> January for February's sessions, which will be due for payment on 1<sup>st</sup> February)*
- For ad-hoc sessions booked after we issue your monthly invoice, payment is due within 7 calendar days of invoicing

#### Ways to pay:

Bank transfer, government tax free vouchers, and all workplace vouchers.

#### Late and Non-payment Fee:

- 10% of total bill after 10 working days
- An additional 10% of total bill after 20 working days and possible suspension of child's place
- After 8 weeks of non-payment court proceedings will be initiated. All legal and court costs will be included in the final bill amount including any tracing fees

#### Early Years Government Funding

We also offer government funding towards sessions for 2-4 year olds, you can find more information on what funding options you're eligible for at the following website: <https://www.childcarechoices.gov.uk/>.

You're able to use funding over 38 weeks, or stretch up to 50 weeks per year. You're also able to split funding if your child attends more than one session. A consumable fee is payable when using funding towards sessions, further details can be found above.
